Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Temperature: 37°C
Atmosphere: Anaerobic

### Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Under anaerobic conditions, withdraw 0.5 ml of #1004 broth from a single test tube (5 to 6 ml) and rehydrate the entire vial contents.
- 3. Aseptically transfer this aliquot back into the broth tube. Additional tubes may be inoculated with 0.5 ml each from the suspension. A slant of #1004 agar may also be inoculated with 0.2 ml. Streak several blood plates to check for colonial



morphology and purity.

4. Incubate tubes under an anaerobic atmosphere at 37°C. Incubate one agar plate anaerobically for colony formation, and one aerobically as an aerobic contamination check.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- · Use of an anaerobic gas chamber, or
- · Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- · Loose screw caps on test tubes in anaerobic chamber,
- · Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- · Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

#### **Notes**

Broth culture becomes turbid and gas is produced after 24 hours growth anaerobically at 37°C.
