Handling Procedures

1. Open vial according to the enclosed instructions.
2. Using a single tube of #1877 broth (5 to 6 ml), withdraw approximately 0.5 ml to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the pellet.
3. Aseptically transfer this aliquot back into the broth tube and mix well.
4. Use several drops of the cell suspension to inoculate a second tube of broth, a slant and/or a plate.
5. Incubate all tubes and plate at 26°C for 1-2 weeks.

Notes

Aerial mycelium is white and substrate is light brown after 10-14 days of incubation.
