Handling Procedures

1. Open vial according to enclosed instructions.

2. Using a single tube of #995 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a #995 agar slant and/or plate.

5. Incubate the tubes and plate at 35°C for 24 hours.

Notes

Colonies on #995 agar are pinpoint, glistening, circular, entire, and smooth. Growth is best observed under dissecting microscope.
