Growth Conditions

Medium:

ATCC Medium 814: GC Agar/Broth Medium

Temperature: 37°C

Atmosphere: 95% Air, 5% CO₂

Handling Procedures

1. Thaw frozen vial at room temperature.
2. Withdraw the entire contents of the vial with a Pasteur or 1.0 mL pipette and transfer to a tube of #814 broth (5 to 6 mL).
3. Use several drops of the suspension to inoculate a #814 agar slant and/or plate.
4. Incubate the tubes and plate at 37°C in an atmosphere of 5% CO₂ for 24-48 hours. Loosen the screw caps during the incubation period.

Notes

Good growth occurs within 48 hours incubation. Colonies are entire, smooth, glistening, and white in color on #814 agar. The increased CO₂ is required for growth.

Brain Heart Infusion (BD 237500) can be used to rehydrate vial contents if #814 broth is not available, but it will not support growth as well as the GC broth.
