Handling Procedures

1. Open vial according to the enclosed instructions.
2. Using a single tube of #1 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #1 agar slant and/or plate. However, it is advisable to establish good growth in the primary broth tube before making subsequent transfers.
5. Incubate all tubes and plate at 26°C. The broth requires 48 to 72 hours to grow. Additional incubation may be required for growth on solid medium.

Notes

If broth tube is left undisturbed, a thick pellicle will form at the surface of the broth tube. The remainder of the tube will remain clear.

Large and small colonies are observed.
