Handling Procedures

PROPAGATION PROCEDURE:

1. Open vial according to enclosed instructions.
 2. Using a single tube of #1027 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Using several drops of the suspension, inoculate a second tube of broth, a slant, and/or a plate.
 5. Incubate all tubes and plate at 55°C for 24-48 hours.

Colonies are circular, smooth, glistening, opaque, and low convex with an insoluble yellow/brown pigmentation.
