Handling Procedures



1. Open vial according to enclosed instructions.

2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.

5. Incubate the tubes and plate at 30°C for 24-48 hours.

Notes

Colonies on #3 agar are circular, entire, glistening, and smooth. Where the colonies are crowded, their color is a pale apricot. Brown crystals are produced.
