Pseudomonas sp. strain 3P is a bacterium that was isolated in South Carolina from a wastewater lagoon. This strain is cited to degrade detergents and surface active agents (US Patent 4,274,954, US Patent 4,317,885, US Patent 4,483,923).

Handling Procedures

1. Open vial.
 2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
 5. Incubate the tubes and plate at 30°C for 24 hours.
