## **Handling Procedures**

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.
- 5. Incubate all tubes and plate at 37°C for 24 hours.

#### Notes

\*Depositor states this strain produces no detectable A region of the cholera enterotoxin (hence the reason for its avirulence), although producing the B region in the same amount as its wild-type (virulent) parent strain.

Colonies on #3 plates are pinpoint, transparent, entire and glistening. Cells are Gram negative, thin, slightly curved rods.

Vibrio cholerae strains do not require NaCl for growth.

Some *Vibrio* strains do not remain viable for more than a few days, even at refrigerator temperatures. To avoid frequent transfers, it is recommended that cells be frozen with a suitable cryoprotectant.
