#### Handling Procedures

2. Using a single tube of #172 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #172 agar slant and/or plate.
- 5. Incubate the tubes and plate at 26°C for 7 days.

#### Notes

Colonies on #172 plates are of variable size and appearance. They are wrinkled, rough, and dull; with some entire, and some irregular. The substrate mycelin is light orange.
