**2. Using a single tube of ATCC #1877 (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**

**3. Aseptically transfer this aliquot back into the broth tube. Mix well.**

**4. Use several drops of the suspension to inoculate a #196 agar slant and/or plate.**

5. Incubate the tubes and plate at 26°C for 10-14 days.

**2. Using a single tube of ATCC #1877 (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**

**3. Aseptically transfer this aliquot back into the broth tube. Mix well.**

**4. Use several drops of the suspension to inoculate a #196 agar slant and/or plate.**

5. Incubate the tubes and plate at 26°C for 10-14 days.
