## Handling Procedures

1. Open vial according to enclosed instructions.
  2. Using a single tube of #1130 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
  3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate an additional broth tube, a #1130 agar slant and/or a plate.
  5. Incubate all tubes and plate at 30°C for 24 hours.
