 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate an additional broth tube, a #1130 agar slant and/or a plate.
 5. Incubate all tubes and plate at 30°C for 24 to 48 hours. Placing broth on a shaker may be beneficial.
