- 2. Using a single tube of #1877 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or glass pipet. Rehydrate the pellet.
- 3. Transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a second tube of broth, a slant and/or a plate.
- 5. Incubate all tubes and plate at 26°C for 7 to 10 days.
- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #1877 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or glass pipet. Rehydrate the pellet.
