1. Open vial according to enclosed instructions.
2. Using a single tube of #25 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or glass pipette. Rehydrate the pellet.
3. Transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a second tube of broth, one or

**two slants and/or a plate.**

5. Incubate all tubes and plate at 30°C for 48 to 72 hours.

**1. Open vial according to enclosed instructions.**

**2. Using a single tube of #25 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or glass pipette. Rehydrate the pellet.**

**3. Transfer this aliquot back into the broth tube. Mix well.**

**4. Use several drops of the suspension to inoculate a second tube of broth, one or two slants and/or a plate.**

5. Incubate all tubes and plate at 30°C for 48 to 72 hours.
