Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of recommended broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or glass pipet. Rehydrate the pellet.
- 3. Transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.



5. Incubate all tubes and plate at 37°C for 24 to 48 hours.

Notes

Crystals form under and around colonies on #1061 agar, because of the Tween 80 in the medium. Cells are short, non-motile rods occurring singly, in pairs, in Vformations, stacked and in small clusters. Additional information on this culture is available on the ATCC[®] web site at www.atcc.org.
