3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a #2 slant, and/or plate

5. Incubate the tubes and plate at the recommended temperature for 24 to 48 hours.

6. After growth has been achieved, additional transfers may be made or cells prepared for storage.
