#### Handling Procedures

- 1. Open vial according to enclosed instructions.
- Using a single tube of #44 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
- 5. Incubate the tubes and plate at 37°C for 24 hours.

#### Notes

Within 24 hours, growth is evident by turbidity in the broth and by colonies on the agar surfaces. Cells are Gram negative, short, plump rods (coccobacillary) occurring singly and in pairs. Colonies are circular, with a convex elevation, an entire margin and a smooth surface. There is marked b-hemolysis on #260 plates.
