Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## **Handling Procedures**

1. Open vial according to enclosed instructions.
2. Using a single tube of #129 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate an additional broth tube, a #129

agar slant and/or a plate.

5. Incubate all tubes and plate at 26°C for 24 to 48 hours.

1. Open vial according to enclosed instructions.

2. Using a single tube of #129 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate an additional broth tube, a #129 agar slant and/or a plate.

5. Incubate all tubes and plate at 26°C for 24 to 48 hours.
