# Handling Procedures

1. Open vial according to enclosed instructions.

2. Using a single tube of #1109 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate an additional broth tube, a #1109 agar slant and/or a plate.

5. Incubate all tubes and plate at 28°C for 48 to 72 hours.

1. Open vial according to enclosed instructions.
