Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #105 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well. Transfers may be made to an additional broth, slant, and/or plate.
4. Incubate all tubes and plate at 26°C for 24 hours.
1. Open vial according to enclosed instructions.

2. Using a single tube of #105 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well. Transfers may be made to an additional broth, slant, and/or plate.
