- 1. Open thawed vial according to enclosed instructions or visit www.atcc.org for instructions.
- 2. Aseptically transfer the entire contents to a 5-6 mL tube of #1148 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
- 3. Use several drops of the primary broth tube to inoculate a #1148 plate and/or



#1148 agar slant.

4. Incubate at 30°C for 4-5 days.
