Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Medium:

ATCC Medium 1490: Modified chopped meat medium

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 37°C

Atmosphere: 95% Air, 5% CO₂; Anaerobic

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #1490 broth (5 to 6 mL), withdraw approximately 0.5 of broth with a sterile syringe and rehydrate the entire pellet using good anaerobic technique.
3. Aseptically transfer this aliquot back into the broth tube (primary tube) and

mix well.

4. Use several drops of the suspension to inoculate a #260 or #18 plate. Additional tubes of #1490 broth can be inoculated using a sterile syringe and transferring 0.5 mL of broth from the primary tube.
5. Incubate the tubes and plate at 37°C for 24 to 48 hours. There should be no growth on non-selective media (#260 or #18) incubated aerobically.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

Notes

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions. Resazurin in the media is a color indicator for anaerobic conditions. Observance of pink color in medium before use or during incubation shows anaerobic conditions have not been met and oxidation has occurred. Medium should be discarded.
