#### Medium:

ATCC Medium 1277: Propionispira medium (ATCC medium 1045) with 0.1% yeast extract and 0.4% sodium lactate

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

**Temperature:** 30°C **Atmosphere:** Anaerobic

### **Handling Procedures**

- 1. Thaw the frozen vial under anaerobic conditions.
- 2. Under anaerobic conditions, withdraw 0.5 mL of the recommended broth from a single test tube (5 to 6 mL) and rehydrate the entire vial contents.
- 3. Aseptically transfer this aliquot back into the broth. Additional tubes may be inoculated with 0.5 mL each from the suspension. 0.1 mL may also be inoculated onto a slant. Streak several blood plates to check for purity.
- 4. Incubate tubes under an anaerobic atmosphere at 30°C. Incubate one agar plate anaerobically for colony formation, and one aerobically for aerobic contamination check.
- 5. Within 48 to 72 hours, growth should be evident by turbidity in the broth and by colonies on the anaerobic agar surfaces at 7 days. No growth occurs on agar plates incubated aerobically.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

#### Notes

Growth needs to be established in broth tubes first, for 48-72 hours before transferring to agar plates. The agar plates take approximately 7 days to grow.



Anaerobe Systems PRAS Brucella Blood Plates (AS-111 or AS-141) can be used to check for colony morphology and purity. Colonies on Brucella agar plates are entire, circular, smooth, white, glistening, and low convex.

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions. Resazurin in the media is a color indicator for anaerobic conditions. Observance of pink color in medium before use or during incubation shows anaerobic conditions have not been met and oxidation has occurred. Medium should be discarded.
