1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.



- Rehydrate the entire pellet with approximately 0.5 mL of #1099 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #1099 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.
- 3. Use several drops of the primary broth tube to inoculate a #1099 plate and/or #1099 agar slant.
- 4. Incubate at 37°C for 48-72 hours in an atmosphere of 5% CO_2 .

Notes

This culture may require growth to be established in broth before growth on agar can be achieved.
