Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

# **Handling Procedures**

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
- 5. Incubate the tubes and plate at 30 to 37°C for 24 hours.

#### Notes

This strain is known to produce two colony types. Both are entire, glistening, and smooth; but one is more opaque in appearance. Also, segmentation can be observed in single colonies.
