Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Temperature: 15-20°C

Atmosphere: Aerobic

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #1299 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a second tube of broth
5. Incubate all tubes at 15-20°C for 7 days then plate the culture onto #1299 agar

for another 7 days.

Notes

Growth on agar may be difficult to achieve even when inoculating from an established broth.

Best growth occurs in the #1299 broth.

The cells are very sensitive and may become club shaped. These cells develop into ghost cells.

This strain is sensitive to room temperature and should be kept below 20°C.
