Escherichia coli strain EDL 931 is a whole-genome sequenced EHEC (STEC with LEE/eae) strain that was isolated from feces. This strain is serotype O157:H7 and was confirmed by PCR to carry the *stx1*, *stx2*, and *eae* genes.

Handling Procedures

1. Open vial according to enclosed instructions.
 2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 24 hours.

This strain is serotype O157:H7. Presence of *eaeA*, *stx1*, and *stx2* genes confirmed by PCR.
