Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Under anaerobic conditions, withdraw 0.5 ml of recommended broth from a single test tube (5 to 6 ml) and rehydrate the entire vial contents.
- 3. Aseptically transfer this aliquot back into the broth tube. A slant and additional broth tubes may be inoculated with 0.2 ml each of the cell suspension. Blood plates may be streaked to check for colonial morphology and purity.

- 4. Incubate tubes and one plate under anaerobic conditions at 37°C. Incubate one blood plate in 5% CO₂ or in air at 37°C.
- 5. Within 48 hours, growth should be evident by turbidity in the broth and growth on agar surfaces. On #260 agar incubated anaerobically, colonies are entire, glistening, circular, smooth, and low convex. No growth should occur on the blood agar plate incubated aerobically.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- · Use of an anaerobic gas chamber, or
- · Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- · Loose screw caps on test tubes in anaerobic chamber,
- · Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- · Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.
