## Growth Conditions

**Medium:**

ATCC Medium 1540: Brucella broth with formate and fumarate

ATCC Medium 1645: Trypticase soy agar with 5% defibrinated sheep blood, formate and fumarate

**Temperature:** 37°C

**Atmosphere:** Anaerobic

## Handling Procedures

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Under anaerobic conditions aseptically rehydrate the entire pellet with

approximately 0.5 mL of #1540 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #1540 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes. Best practice dictates the use of pre-reduced media.

3. Use several drops of the primary broth tube to inoculate a #1645 plate and/or #1645 agar slant.
4. Incubate in an anaerobic atmosphere at 37°C for 2 to 4 days. Incubate one agar plate aerobically at 37°C to check for contamination.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

### Notes

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions.
