Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### Handling Procedures

1. Open vial according to enclosed instructions.
2. Under anaerobic conditions, withdraw 0.5 ml of #1257 broth from a single test tube (5 to 6 ml) and rehydrate the vial contents.
3. Aseptically transfer this aliquot back into the broth tube. Additional tubes may be inoculated with 0.5 ml each from the suspension. A slant of #1257 may also be inoculated with 0.2 ml. Streak one or more #1257 or blood plates to check for colonial morphology and purity.
4. Incubate tubes under an anaerobic atmosphere at 37°C. Incubate one #1257 or

**blood agar plate anaerobically for viability, purity, and colonial morphology.**  
**Incubate one blood agar plate aerobically for contamination check.**

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system

hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic

gas pack jar, or

- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

---

### Notes

Within 72 hours, growth is evident by turbidity in the broth. Colonies on the anaerobic blood plate are entire, smooth, glistening, low convex, circular, and translucent. The cells are slender curved rods with tapered ends and variable in shape and size. They stain Gram negative. No growth occurs on the blood agar plate incubated aerobically.
