Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Medium:

Anaerobe Systems Brucella Blood Agar Plates (BRU) (AS-111 or AS-141)

ATCC Medium 1878: ATCC Medium 1015 with 10% heat-inactivated rabbit serum

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 37°C

Atmosphere: Anaerobic

Handling Procedures

1. Open vial according to enclosed instructions.
2. Under anaerobic conditions, withdraw 0.5 mL of the recommended broth from a single test tube (5 to 6 mL) and rehydrate the entire vial contents.

3. Aseptically transfer this aliquot back into the broth. Additional tubes may be inoculated with 0.5 mL each from the suspension. A slant may be inoculated with 0.1 mL. Streak 2 agar plates to check for colony morphology and purity.
4. Incubate tubes under an anaerobic atmosphere at 37°C for 24 to 48 hours. Incubate one agar plate anaerobically for colony formation, and the other agar plate aerobically for a contamination check.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

Notes

Anaerobe Systems Brucella Blood Plate (AS-111 or AS-141) can be used to analyze colony morphology and purity.

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions.
