ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### **Growth Conditions**

Medium: ATCC Medium 1878: ATCC Medium 1015 with 10% heat-inactivated rabbit serum ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood Temperature: 37°C Atmosphere: Anaerobic

#### Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Under anaerobic conditions, withdraw 0.5 mL of the recommended broth from a single test tube (5 to 6 mL) and rehydrate the entire vial contents.
- 3. Aseptically transfer this aliquot back into the broth. Additional tubes may be

inoculated with 0.5 mL each from the suspension. A slant may be inoculated with 0.1 mL. Streak 2 agar plates to check for colony morphology and purity.

Incubate tubes under an anaerobic atmosphere at 37°C for 24 to 48 hours.
 Incubate one agar plate anaerobically for colony formation, and the other agar plate aerobically for a contamination check.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

#### Notes

Anaerobe Systems Brucella Blood Plate (AS-111 or AS-141) can be used to analyze colony morphology and purity.

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions.
