Handling Procedures

1. Open thawed vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Aseptically transfer the entire contents to a 5-6 mL tube of #1099 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.

3. Use several drops of the primary broth tube to inoculate a #1099 plate and/or #1099 agar slant.
 4. Incubate at 30°C for 24-72 hours in an atmosphere of 5% CO₂.

Notes

The preferred medium for growth is CYE, on which this strain is fluorescent. No growth will occur on sheep blood agar.
