Handling Procedures

1. Open vial according to enclosed instructions.
 2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

Two colony types are observed on #3 agar: a) translucent and medium-sized; b) opaque and large. Both are entire, glistening, circular, smooth, and low convex. Additional information on this culture is available on the ATCC web site at www.atcc.org.
