*Escherichia coli* strain H10407 is an enterotoxigenic *E. coli* (ETEC) that was isolated from feces and can be used in the detection of LT toxin and *Vibrio cholerae* ctx A11.

This strain produces heat-labile and heat-stable enterotoxins.

## Handling Procedures

1. Open vial.
2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0

- mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
  5. Incubate the tubes and plate at 37°C for 24 hours.
