ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 37°C

Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #2023 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
4. Use several drops of this suspension to inoculate an additional broth tube, a #260

agar slant and/or a plate.

5. Incubate the tubes and plate at 37°C for 24 hours. An atmosphere of 5% CO₂ is beneficial but is not essential for growth.

Notes

Colonies are tiny, clear, smooth, and entire with slight greening of the blood agar.
