ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 37°C

Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. From a single tube of #2023 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
- 4. Use several drops of this suspension to inoculate an additional broth tube, a #260



agar slant and/or a plate.

5. Incubate the tubes and plate at 37° C for 24 hours. An atmosphere of 5% CO_2 is beneficial but is not essential for growth.

Notes

Colonies are tiny, clear, smooth, and entire with slight greening of the blood agar.
