For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open vial according to enclosed instructions.

2. Using a single tube of #18 broth, withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the pellet.

3. Aseptically transfer 0.2 of this suspension to #814 slant(s), and/or plates. Agar

plates should be inoculated with 0.1 ml of this suspension per plate.

4. Incubate at 37°C with 5% CO₂ for 24 hours.

Notes

Colonies on #814 plates are smooth, low convex, translucent, and grayish.

If a broth culture is desired, use Medium #814 formulation without the agar, or HTM (Haemophilus Test Broth). To make HTM, first a fresh hematin stock solution is prepared by dissolving 50 mg of hematin

powder in 100 ml of 0.01 N (0.01 mol/L) NaOH with heat and stirring until the powder is dissolved thoroughly. Thirty milliliters of the hematin stock solution is added to 1 L of Mueller-Hinton Broth with 5 g of yeast extract. After autoclaving and cooling, aseptically add 3 ml of a NAD (nicotinamide adenine dinucleotide) stock solution (50 mg of NAD dissolved in 10 ml of distilled water; filter sterilized).
