Handling Procedures

1. Open vial according to enclosed instructions.

2. Using a single tube of #5129 or #814 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use 0.2 ml of the suspension to inoculate a #814 slant, and/or 0.1 ml for a plate.

5. Incubate all tubes and plate at 37° C with 5% CO₂ for 24 to 48 hours. Assure that screw caps are loose during incubation period.

Notes

Colonies on #814 agar are entire, glistening, circular, smooth, and raised.

Brain Heart Infusion (BD 237500) can be used to rehydrate vial contents if #5129 broth is not available, but it will not support growth as well as the HTM broth.
