For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## **Growth Conditions**

Medium: ATCC Medium 814: GC Agar/Broth Medium Temperature: 37°C Atmosphere: 95% Air, 5% CO<sub>2</sub>

#### Handling Procedures

- 1. Open vial according to enclosed instructions.
- Using a single tube of #814 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. As eptically transfer this aliquot back into the broth tube. Mix well. Incubate broth tube at 37°C for 24 hours in an atmosphere of 5%  $CO_2$ .

- 4. Use several drops of the suspension to inoculate a #814 agar slant and/or plate.
- 5. Incubate the agar slants and/or plates at  $37^{\circ}$ C for 48 hours in the atmosphere of 5% CO<sub>2</sub>. Loosen the screw caps during the incubation period.

#### Notes

Colonies on #814 plates are circular, glistening, flat and smooth, turning rough with age.
