Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open vial according to enclosed instructions.

2. Under anaerobic conditions, withdraw 0.5 ml of recommended broth from a single test tube (5 to 6 ml) and rehydrate the entire vial contents.

3. Aseptically transfer this aliquot back into the broth tube. An aerobic blood plate may be streaked to check for purity.



4. Incubate tube under anaerobic conditions at 37°C for 24hrs. Incubate blood plate aerobically at 37°C.

5. Within 24-48 hours, growth should be evident by turbidity in the broth. A second tube, a slant, and a pre-reduced blood plate may be inoculated with .1mls each of the cell suspension. This strain requires a primary growth period in the initial broth before it will grow on any subculture attempts.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

 \cdot Use of an anaerobic gas chamber, or

· Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

 \cdot Loose screw caps on test tubes in anaerobic chamber,

 \cdot Loose screw caps on test tubes in an activated anaerobic gas pack jar, or

 \cdot Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

Notes

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions. Resazurin in the media is a color indicator for anaerobic conditions. Observance of pink color in medium before use or during incubation shows anaerobic conditions have not been met and oxidation has occurred. Medium should be discarded.

On agar surfaces, colonies are pinpoint, circular, entire, and convex with no hemolysis. No growth should occur on the blood agar plate incubated aerobically.
