ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
- 2. Rehydrate the entire pellet with approximately 0.5 mL of #18 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #18 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to

these secondary tubes.

- 3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
- 4. Incubate at 26°C for 10 to 14 days.

Notes

To obtain a biphasic culture, add 0.4 mL of the suspension to a #260 slant.

The use of FRESH media is of primary importance.

ATCC Medium #4 (Trypticase Soy Agar with 5% Defibrinated Rabbit Blood) may also be used.

Once good growth is obtained, transfer or freeze the culture. Adding an equal amount of 20% sterile glycerol to pooled broth from several biphasic slants, followed by freezing in liquid nitrogen or ultra-low temperature freezer, is recommended.
