Handling Procedures

1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.

2. Rehydrate the entire pellet with approximately 0.5 mL of #2714 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #2714 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
 3. Use several drops of the primary broth tube to inoculate a #2721 plate and/or #2721 and/or #90 agar slant.
 4. Incubate at 37°C for 4 weeks.

Notes

Colonies on #2721 agar are size-variable, rough, wrinkled, irregular, dry, undulate, dull, hilly, and opaque.

With the 40 mM solution of sodium pyruvate added to the media formulation, there should be abundant growth as specified in the reference (Keating LA, *et al.* Mol Microbiol 56(1): 163-174, 2005). Without the sodium pyruvate added to the formulation, there will be some growth, but it should be poor.
