## Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #2714 broth (5 to 6 ml), withdraw approximately 0.5 to



- 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #2721 agar slant and/or plate.
- 5. Incubate the tubes and plate at 37°C for 4 weeks.

#### Notes

With the 40 mM solution of sodium pyruvate added to the media formulation, there should be abundant growth as specified in the reference (1). Without the sodium pyruvate added to the formulation, there will be some growth, but it should be poor.
