ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

# Handling Procedures

- 1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
- 2. Rehydrate the entire pellet with approximately 0.5 mL of #1395 broth.

  Aseptically transfer the entire contents to a 5-6 mL tube of #1395 broth.

  Additional test tubes can be inoculated by transferring 0.5 mL of the primary

broth tube to these secondary tubes.

- 3. Use several drops of the primary broth tube to inoculate a #173 plate and/or #173 agar slant.
- 4. Incubate at 37°C for 4-6 weeks.

#### Notes

This strain grows best in broth upon opening. Growth on solid agar is best achieved after inoculation from an actively growing broth culture that has been incubated for 4-6 weeks.

ATCC® Medium 2714 and ATCC® Medium 2721 may be used as alternate media to attempt to enhance growth by the addition of 40 mM sodium pyruvate.
