Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open vial according to enclosed instructions.
 2. Using a single tube of #2 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #2 agar slant and/or plate.
 5. Incubate the tubes and plate at 26°C for 24-48 hours.

Notes

After growth has been achieved, additional transfers may be made or cell may be prepared for storage. Most *Vibrio* species will die rapidly once the stationary phase is reached, even at refrigerator temperatures. To avoid frequent transfers, it is recommended that cells are frozen with a suitable cryoprotectant.

Colonies on #2 agar appear entire, smooth, pinpoint, convex, and translucent.
