2. Using a single tube of #1475 broth (5 to 6 ml), withdraw approximately 0.5 to

- 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.
 5. Incubate all tubes and plate at 28°C for 48 hours.
