4001 Handling Procedures

1. Open vial according to enclosed instructions.

2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. Transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a second tube of broth and a slant, and/or plate of #27 agar.

5. Incubate all tubes and plate at 30°C for 3 to 5 days.

Notes

Colonies on #27 plates are rough and filamentous, opaque and pink, with dense centers. Cells are cocci or coccobacilli.
