Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

**Frozen ampoules** packed in dry ice should either be thawed immediately or stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampoules may be stored at or below -70°C for approximately one week. **Do not under any circumstance store frozen ampoules at refrigerator freezer temperatures** 



**(generally -20°C).** Storage of frozen material at this temperature will result in the death of the culture.

- 1. To thaw a frozen ampoule, place in a **25°C to 30°C** water bath, until just thawed (approximately 5 minutes). Immerse the ampoule just sufficient to cover the frozen material. Do not agitate the ampoule.
- 2. Immediately after thawing, wipe down ampoule with 70% ethanol and aseptically transfer at least 50  $\mu$ L (or any amount desired up to all) of the content onto a plate or broth with medium recommended.
- 3. Incubate the inoculum/strain at the temperature and conditions recommended. Inspect for growth of the inoculum/strain regularly. The sign of viability is noticeable typically after 1-2 days of incubation. However, the time necessary for significant growth will vary from strain to strain.
